Meeting Minutes

06.26.2025

Type of Meeting: Board of Directors Meeting

- I. Call to order: 5:43 pm
- II. Roll call:
 - A. Present: Directors Bridges, Howe, McQuinn, Terhune.
 - B. Absent Director Williams.
- III. Additions to, Deletions from, or Changes to the Agenda
 - A. None
- IV. Approval of minutes from last meeting:
 - A. Director Terhune motions to approve the previous meeting's minutes. Director Howes seconds. Director Bridges approves the minutes.
- V. Committee Updates:
 - A. Operations Committee:
 1. Accept Resignation of Committee Chair by Chase Ramirez.
 - a) Director Bridges motions to approve, Director McQuinn seconds, all are in favor.
 - b) The board discussed how grateful they are for Ramirez's work on the Pioneer course.
 2. Pioneer DGC:
 - a) Tee Signs Poles: We are in need of a solution for the poles. Those we have are too large so would need to be modified.

The other option would be to purchase basket conversion kits to be able to pull the signs when in need for an event at the course. Director Bridges will work on a proposal for the board to review and vote on.

- b) Riding Mower: Discussed the possibility of purchasing a riding mower to maintain the course on a more regular basis.
- c) Most & Found discs: Blake Bridges is working on a lost and found box to attach to the course's kiosk.

3. Cascades DGC

- a) Director Bridges installed two more tone poles at the course. There are now 12 holes set at the course.
- b) Tee Signs: Discussed the need for signs. Director Bridges will make temporary signs out of laminated paper.
- c) Work Day: The course needs to be cleaned up to comply with the contract we have with the USFS

C. Outreach Committee:

- 1. Rich Bar Taproom Basket collab: Basket is installed and ready to go. The club needs to provide vinyl stickers with PDG info. The club will provide used putters for the patrons at Richbar to be able to use. These putters will also have PDG stickers on them.

D. Events Committee:

- 1. Summer Putting League at Rich Bar Taproom: Ran into some wording issues on the flyer. The venue's insurance doesn't allow gambling and the words Fee, Buy-in, Pay-outs, aren't allowed. We'll change the wording to say Donation instead.

The League will run for about 10 to 12 weeks, every Thursday at 5:30pm starting July 10th. We'll use a one or two basket max for the league format.

- 2. MVP Circuit challenge: This will happen August 30th. So far there are 4 competitors registered.
