### Type of Meeting: Board of Directors Meeting

- V. Committee Updates:
  - A. Operations Committee:
    1. Cascades DGC Updates:
      - a) Howe reached out to Collen but there's no updates on the thinning project..
      - b) Director Bridges is suggesting to use personal money to buy the baskets and materials, then get reimbursed through the RAC, with no interest. It will be stored at Director Bridges' house until we're ready to install.
      - c) We need to move Hole #8. USFS archeologists need to be present when moving this hole to approve.
      - d) The river side of the course needs to be cleaned up by us. It will not be thinned by USFS
      - e) Hole 13 also needs access stairs.

- f) Director Bridges received an email asking about how they could help with signage for a disc golf course using a grant from the Trails Stewardship. It's too late for this time around but maybe later.
2. Pioneer DGC Updates: Saturday cleaned up the course and fixed the tee-pad of 9. It was gopher damage. We'll have to keep an eye on it. We still need to get the tee-pad signs and then it should be done.
